The charterer promises to comply with the terms and conditions of this agreement. The Terms of Agreement below are hereby incorporated in to this contract. Contract is only valid with page one and two together and both pages signed.

1. To confirm your cruise date, a deposit of 50% is due upon signing of this agreement.
2. Deposit refunds shall be granted if contract is canceled with-in 72 hours of signing of this agreement.
Remaining balance stipulated in agreement shall be paid in full no later then 15 days prior to agreed upon chartered date.
3. No one under the age of 21 will be served alcohol in accordance with NYS liquor authority regulations and state laws.
4. No outside alcohol shall be permitted to be brought on board from outside sources due to NYS liquor authority licensing.
5. We support and adhere to all Federal, State and Local laws as applicable and adhere to US Coast Guard Zero Tolerance Drug and Alcohol requirements.
6. HUDSON CRUISES INCORPORATED reserves the right to require a security (damage) deposit from any group prior to any charter.
7. Our vessels are not handicap accessible. Every effort will be made to accommodate all passengers as is reasonably possible with regards to vessel construction and layout, crew availability, weather and sea conditions, etc.
8. All information, i.e., schedules, prices, vendors, are subject to change without notice.
9. The captain of the vessel is directly responsible for, and is the final authority as to, the operation of the charter. At his/her discretion, he/she may delay, postpone or cancel charter due to any circumstances that may arise (weather, sea conditions, unlawful drug use, emergencies, mechanical problems, etc). Guidance and Safety Instructions from other crew members shall be adhered to as they are directly responsible to the Captain of the vessel.
